Thank you for your email in connection to Swanwick Parish Councils Neighbourhood Area Designation Application.

A report went to the Full Council meeting on Wednesday 15th May 2013 requesting Delegated Powers to be given to the Executive Director (Operations) in consultation with the Cabinet Member for Developing Places to Live and Work and the Local Plan Member/Officer Working Group to approve the designation of a Neighbourhood Area.

This was agreed, therefore the next Member/Officer Working Group meeting is on Thursday 23rd May 2013 where I would expect this decision will be endorsed and the application approved, once we are aware of this decision we will be in touch with you.

The resources we will be providing are as agreed by Full Council on 18th January 2012:

1. Provision of access to existing data and supporting evidence obtained through the preparation of the Core Strategy
2. Providing direction to other relevant information sources and contacts
3. Access to officers within the Community Planning team to provide general advice
4. Attendance at meetings held by parish/town councils and local communities on an exceptional basis, where sufficient information and advice cannot be given by e-mail, telephone or letter
5. Providing an overview of neighbourhood planning on the Council's website.

In terms of financial contributions, Parish Councils can now apply for grants from Locality up to £7,000 to help areas create neighbourhood plans.
